



### City of Fall River, In City Council

(Councilors Shawn E. Cadime and Cliff Ponte)

WHEREAS, a comprehensive investigation conducted by private investigator Daniel Lowney revealed serious allegations of misconduct, misuse of City resources, environmental hazards, procurement violations, theft, favoritism, and systemic issues within the Fall River Department of Community Maintenance (DCM), and

WHEREAS, these allegations raise concerns about the integrity, oversight, and accountability of City operations, as well as the City's handling of internal investigations and transparency with the public, and

WHEREAS, it is essential to ensure that public funds are being managed properly, that environmental and safety standards are upheld, and that appropriate accountability measures are in place to prevent future misconduct, and

WHEREAS, the Massachusetts State Auditor has the authority and responsibility to conduct audits of municipal departments to ensure proper management, compliance with laws, and fiscal accountability, now therefore

BE IT RESOLVED, that the City Council of the City of Fall River hereby formally requests that the Massachusetts State Auditor:

- Initiate a comprehensive, independent audit of the Fall River Department of Community Maintenance (DCM), including but not limited to:
  - a. Review of procurement practices and contracts
  - b. Use and management of City resources and equipment
  - c. Environmental compliance and hazardous materials handling
  - d. Employee conduct and workplace environment
  - e. Internal controls, oversight, and accountability mechanisms
- Investigate the circumstances surrounding the investigation process and the City's handling of the related reports and documents, including compliance with public records laws and transparency obligations.
- Provide a public report of findings and recommendations to the City Council and the residents of Fall River to ensure transparency and accountability, and

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit a copy of this resolution to the Massachusetts State Auditor's Office, and

BE IT FURTHER RESOLVED, that the report be submitted to the Fall River Police Department, U.S. Attorney's Office, Attorney General, District Attorney and the Inspector General with a requested response from said agencies by August 15, 2025.
